TERMS & CONDITIONS

Relating to the Sale of Goods and Services by **WILTSHIRE AIRCRAFT MAINTENANCE LTD (WAM Ltd)**

1 Contract term, Variations and representations.

- (a) No order in pursuance of any quotation or otherwise shall be binding on WAM Ltd unless and until such order is accepted by WAM Ltd.
- (b) Where the buyer of Goods and Services, has not given written instructions to WAM Ltd, then verbal instructions will apply.
- (c) WAM Ltd, reserves the right to correct any clerical or typographical errors Made by its employees.
- (d) Buyers of WAM Ltds Goods and Services, may wish to supply own goods purchased, should WAM Ltd agree (Subject to said part availability being no longer than WAM Lt suppliers availability) then a 10% handling charge may be applied.
- (e) WAM Ltd, Are authorised to carry out any rectification work required by current and past Airworthiness Directives (Ads) and Service Bulletins (SBs).

2 Quotations and Prices

- (a) WAM Ltd may supply quotations for Goods and Services, and reserves the right to change said quotation after 30 days.
- (b) WAM Ltd reserves the right to change said quotation, if currency exchanges are involved.
- (c) No estimate or quotation given by WAM Ltd is binding until agreed by purchaser and WAM Ltd.
- (d) WAM Ltd reserves the right to increase its charges to take into account any increase in the cost of Goods and Services charged to WAM Ltd.
- (e) WAM Ltd reserves the right to increase its charges on an annual basis in line with published RPI (Retail price Index)

3 Additional work

- (a) As part of its CAA approval WAM Ltd is required to check and report all information relating to the Goods and Services it offers, should said information require additional work to be carried out, then WAM Ltd is legally required to carry out any such works.
- (b) WAM Ltd, will endeavor to inform buyers any such additional works over £300.

4 Payment

- (a) **WAM Ltd require payment in full on receipt of invoice. Time of payment shall be the Essence of the contract.**
- (b) Payments not recieved within 30 Days will incur overdue payment interest calculated at Lloyd Bank Base Rate plus 8%

5 Failure to Pay

- (a) WAM Ltd reserves the right to hold Goods and Services and Property until full payment has been Recieved.
- (b) In the Event of non -payment for any reason, including Bankruptcy, WAMLtd reserves the right to the Title of goods and materials supplied, and may enter any aircraft at any location to remove and recover.

6 Retention of title

- (a) WAM Ltd require that all Goods and Services supplied remain their property until full payment has been recieved.
- (b) WAM Ltd reserves the right to reclaim said Goods and Services to recover costs as claimed.

7 Limitation of Liability

- (a) WAM Ltd will endeavour to honor any "Warrenties" issued by suppliers of Goods and Services to WAM Ltd.

8 Insurance

- (a) Whilst every reasonable care is taken by WAM Ltd, in the storage and handling of Customers property, WAM Ltd, will not hold itself responsible for loss or damage to such property whilst in transit to, or from our Facility, or on our property.
